

## **TALENT RELEASE**

### **1. PERMISSION TO MAKE AND USE RECORDINGS.**

For good and valuable consideration, receipt of which is hereby acknowledged and received, the Guardian grants the Filmmaker and its employees, agents, independent contractors, licensees, successors, and assigns (the "Filmmaker's Agents") permission and the full and irrevocable right to record the Minor's likeness, image, voice, appearance, and performance on film, videotape, audiotape, computer files, or other media (the "Recordings") and to use, reuse, edit, exhibit, license, distribute, and/or otherwise exploit the Recordings, in whole or in part and in conjunction with the Minor's name (or fictitious name) and biographical material, for any lawful purpose whatsoever and in all forms of media now known or unknown, including, but not limited to, Internet, live performance, live presentation, film, publicity, advertising, fundraising in connection therewith (the "Recordings Use").

### **2. RIGHTS AND OBLIGATIONS.**

The Guardian grants and assigns to the Filmmaker and the Filmmaker's Agents all right, title, and interest in and to the Recordings, including, but not limited to, copyright. The Guardian understands and agrees that the Recordings shall be the sole property of the Filmmaker and that neither the Guardian nor the Minor shall have any right to: (i) inspect or approve the Recordings; (ii) inspect or approve any other recordings, text, graphics, images, or other content created in connection with or combined with the Recordings; or (iii) receive any royalties or other compensation arising from or related to the Recordings Use.

### **3. RELEASE.**

The Guardian agrees to release, discharge, and hold harmless the Filmmaker and the Filmmaker's Agents from any and all damages, liabilities, costs, expenses, claims, and/or judgments of any kind or nature whatsoever arising from the Recordings Use, including, but not limited to, those based on copyright infringement, invasion of privacy, right of publicity, libel, defamation, or false light. The Guardian acknowledges and agrees that this Release is binding on the Guardian and the Minor, and their respective heirs, legal representatives, and assigns.

### **4. GUARDIAN'S REPRESENTATIONS AND WARRANTIES.**

The Guardian hereby represents that [he][she]: (i) is a legal adult and has the full legal capacity to execute this Release; (ii) is the parent or legally appointed guardian of the

Minor; and (iii) has the full legal authority to execute this Release on the Minor's behalf. The Guardian further represents that the rights granted under this Release will not conflict with or violate any other commitment the Minor has with any other party. The Guardian has read this Release prior to signing it and fully understands its contents, meaning, and impact.
